- A. SCR Marketing Committee Update Michelle

  - Dave volunteered to get an estimate for SCR magnets.
  - Cedric contacted Tropical Teez and received a quote of \$4-\$4.50/shirt for an order of 500 2-sided,
     2-color cotton T shirt.
    - Hard copy of proposed design distributed: redlines noted, other color schemes discussed.
    - The athletic shirts used for some of last year's SCR races were bought in bulk by Marlene then Tropical Teez did the screen-printing for \$2/shirt.
    - Christy suggested that we get a small order (~400 shirts, size distribution TBD) and then
      order more as needed.
    - Cedric to revise order information and get another quote: for colored t-shirts, and for shirts with pockets.

- A. 2008-2009 SCR Budget Discussion
